

UK Companies Operating a Matching Gift Scheme

Can your company match donations to the Fitzjohn's School Association?

The following companies in the United Kingdom are those that we understand currently match gifts donated by their employees – however, this list is not definitive!

If your employer is not listed, please contact your Human Resources department to find out if they operate a matching gift scheme. A number of companies abroad, especially in the US, also operate similar schemes.

In most cases, the company will match your donation pound for pound up to a specific level; a handful of organisations even double-match. Some companies will also match money that you have helped raise at an event. For example if you helped on the raffle stall and it raised £2,000 the company would match that with no direct financial contribution from you. Your time is valuable too!

Please contact your Human Resources department to make a matching gift, they should be able to give you a form to fill in confirming the gift you have made. You then send that form to us so we can confirm receipt of the gift. That's all there is to it!
